

## Dog Agility Club of Ventura (DACV) AKC Agility Trial

---

Saturday & Sunday, July 19 and 20, 2025

Community Center Park, Camarillo

Trial Hours 7:00 AM – 4:00 PM

1. **DO NOT ARRIVE AT THE PARK BEFORE 7 AM.** Please be respectful of this neighborhood and do not idle in front of someone's house while waiting to get into the site or leave barking dogs in your car while you are off somewhere. If you are in the parking lot before 7 AM you may be ticketed by the police. ***Neighbors have complained recently about dogs barking in the early hours of the morning on weekends.*** If you know your dogs bark when you are away from them, ask a friend to stay with them to keep them quiet while you set up. Do the same for them. *Everyone's cooperation is needed to retain this site!*
2. **PARKING ALONG THE BACK FENCE IS NO LONGER ALLOWED.** We cannot tape it off – the general public can park there, but no dogs in cars along the fence between the parking lot and the neighborhood. No parking along curbs – you may load/unload, then move into a designated parking spot. Seniors on Saturdays and church members on Sunday need to be able to load/unload along the curb in front of the Senior Center and auditorium.
3. **NO DOGS LEFT IN CARS UNATTENDED ON MODESTO.** Modesto runs along the backside of the park – past the Jumpers Ring. If you park on Modesto, bring a crate or ex-pen and set up under the trees. This area is also close to the neighborhood houses and regulars who set up there know to keep their dogs quiet.
4. **THIS SITE DOES NOT ALLOW TARPS AS GROUND COVERS – ALL MATS MUST BE TAKEN UP AT NIGHT.**  
\*\*\* Please take up your mats each night from your set up; ***switch the spot of your crates each night*** \*\*\*

### **THERE IS A WAIT LIST FOR THIS TRIAL**

If you pull your dog for any reason, ***and there is someone to take your place***, you will receive a full refund for the class(es) you pull. ## MAPS

Exhibitor maps for the day will be sent by 6 AM via email the morning of the trial and will be available on the Agility Gate App. They will also be posted on the trailer that morning. Printed maps will NOT be available at the trial.

## NOVICE AND OPEN COMPETITORS

## MOVE-UPS

---

All pre-show move-ups must be received **by 6 PM, Monday, July 14**. The AKC requires move-ups to be in writing. You may send an email for a move-up to [stephnishimoto@gmail.com](mailto:stephnishimoto@gmail.com) with your name, your dog's call name, the name and date of the trial and what class you want the dog moved to. If you miss the deadline for move-ups, you may move your dog up on the first day of the show for any subsequent days even if you are not showing a dog that day. A friend may do the move-up for you if you are not there. You may NOT move up the day of the show for that day.

There will be day-to-day move-ups at the show, provided the Trial Secretary receives the move-up within 15 minutes after the end of the last class. There will be no move-ups in the morning before the start of the trial.

**However**, a dog which has been entered in a Novice "A" class for which it is not eligible to be entered in due to class restrictions on the dog or handler, may be moved to the Novice "B" class under the following conditions: The request for the move must be in writing and presented to the superintendent or Trial Secretary at least 30 minutes prior to the start of each trial. The request must state the reason and justification for the move from the Novice "A" to the Novice "B" class.

## DIRECTIONS: Community Center Park, 1605 East Burnley Street, Camarillo, CA 93010

---

From SOUTH - Take US HWY 101 North, exit Carmen (Exit 54), turn right onto Carmen. Go to Burnley Ave (first Stop sign) and turn right. Turn left into the parking lot.

From NORTH – Take US HWY 101 South, exit Carmen (Exit 54), turn left off the ramp onto Ventura Blvd and turn left on Carmen. Go to Burnley Ave (first Stop sign) and turn right. Turn left into the parking lot.

## SET-UP & SECURITY

---

Setting up the agility rings is noon-3 PM on Friday. If you would like to help unload the trailer you can come at noon and help unload and set up. **Anyone else will not be able to set up before 3 PM.**

**ALL MATS MUST BE REMOVED EVERY NIGHT.** *Please tip your crates on their side so the solid bottoms are off the grass or move them so they are not on the same spot for 24 hours.* This is a wide-open public park. There is no security guard --leave things at your own risk

## MEASURING

---

The judge this weekend is a Volunteer Measuring Official (VMO). She will be available to measure your dog(s) between classes (before T2B or FAST, before the Master/Excellent classes, before Open and Novice classes). **If you need to be measured, you MUST be measured before your first run.** If you need help getting measured, come by the scoring table and we will be happy to help you.
