The parking spaces next to their field are reserved for the players and their families. There will also be regular baseball games throughout the weekend. Please be respectful of the community members using their park. Plan accordingly as parking will be tight. You may have to park along Eubanks and bring your set up to the field.

SCHEDULE OF EVENTS

Thank you for your entry. You should have received the second confirmation of your entry into the Dog Agility Club of Ventura (DACV) AKC agility trial April 18-19, 2026 at Freedom Park East in Camarillo. MAPS

Exhibitor maps for the day will be sent by 6 AM via email the morning of the trial and will be available on the Agility Gate App. They will also be posted on the trailer that morning. Printed maps will NOT be available at the trial.

COVID-19

If you have tested positive for COVID-19 or exhibit symptoms that morning, do not attend the trial! We will give a full refund with proof of a positive test.

NOVICE AND OPEN COMPETITORS

If you have any questions or need help with anything please come to the scoring table and someone there will be happy to help you. If this confirmation is confusing to you and you need some further explanation email stephnishimoto@gmail.com and Stephanie will help you make sense of it.

MOVE-UPS

All pre-show move-ups must be received **by 6 PM, Monday, April 13**. The AKC requires move-ups to be in writing. You may send an email for a move-up to stephnishimoto@gmail.com with your name, your dog's call name, the full name and date of the trial and what class you want the dog moved to. If you miss the deadline for move-ups, you may move your dog up on the first day of the show for any subsequent days even if you are not showing a dog that day. A friend may do the move-up for you if you are not there. You may NOT move up the day of the show for that day.

There will be day-to-day move-ups at the show, provided the Trial Secretary receives the move-up within 15 minutes

after the end of the last class. There will be no move-ups in the morning before the start of the trial.

However, a dog which has been entered in a Novice "A" class for which it is not eligible to be entered in due to class restrictions on the dog or handler, may be moved to the Novice "B" class under the following conditions: The request for the move must be in writing and presented to the superintendent or Trial Secretary at least 30 minutes prior to the start of each trial. The request must state the reason and justification for the move from the Novice "A" to the Novice "B" class.

DIRECTIONS: Freedom Park East, 275 E Pleasant Valley Road, Camarillo, CA 93010

From US-101 N toward Ventura: Take Las Posas Road exit and turn left. Go to Pleasant Valley Road and turn right. Turn right on Eubanks (2nd stop light). Turn left into the driveway to the park.

From US-101 S toward LA: Take Las Posas Road exit and turn right. Go to Pleasant Valley Road and turn right. Turn right on Eubanks (2nd stop light). Turn left into the driveway to the park.

SET-UP & SECURITY

Set-up is noon-3 PM on Friday. If you would like to help unload the trailer you can come at noon and help unload and set up. Anyone else will not be able to set up before 3 PM. Do not leave mats on the ground overnight to save your set-up spot. Crates should be tipped on their sides.

MEASURING

The judge this weekend is not a Volunteer Measuring Official (VMO). He will be available to measure your dog(s) for this weekend ONLY -- between classes (before T2B or FAST, before the Master/Excellent Classes, before Open and Novice Classes). If you need to be measured, you MUST be measured before your first run (including FAST and T2B). If you need help getting measured, come by the scoring table and we will be happy to help you.
