INDUSTRY HILLS EXPO CENTER RULES

- **NO DOGS IN THE BATHROOMS!**
- **NO PEOPLE AND/OR DOGS ALLOWED ON THE HORSE TRAILS**
- **NO DOGS OFF LEASH**
- **DOGS ARE ALLOWED IN THE AGILITY ARENA AREA AND MAIN PARKING LOT ONLY**
- **NO LOADING/UNLOADING BEHIND THE BLEACHERS OR ON THE DIRT ROAD THAT RUNS ALONG THE ARENA**
- **THE ONLY PLACE CARS ARE ALLOWED IS IN THE MAIN PARKING LOT IN A DESIGNATED PARKING SPACE**

MAPS:

Exhibitor maps for the day will be sent by 6 AM via email the morning of the trial and will be available on the Agility Gate App. They will also be posted on the trailer that morning. Printed maps will NOT be available at the trial.

NOVICE AND OPEN COMPETITORS

If you have any questions or need help with anything, please come to the scoring booth and someone there will be happy to help you. If this confirmation is confusing to you and you need some further explanation email stephnishimoto@gmail.com and Stephanie will help you make sense of it.

MOVE-UPS

All pre-show move ups **must be received by 6 PM Monday, January 26.** The AKC requires move-ups to be *in writing*. You may send an email for a move-up to stephnishimoto@gmail.com with your name, your dog's call name, the full name and date of the trial and what class you want the dog to be moved to. If you miss the deadline for move-ups, you may move your dog up the first day of the show for any subsequent days even if you are not showing a dog that day. In addition, a friend may do the move-up for you if you are not there. You may not move up the day of the show for that day.

There will be day-to-day move-ups at the show provided the Trial Secretary receives them within 15 minutes after the end of the last class. There will be no move-ups in the morning before the start of the trial.

However, a dog which has been entered in a Novice A class for which it is not eligible to be entered in due to class restrictions on the dog or handler may be moved to the Novice B class under the following conditions: the

request for the move must be in writing and presented to the Superintendent or Trial Secretary at least 30 minutes prior to the start of each trial. The request must state the reason and justification for the move from the Novice A class to the Novice B class.

COVID-19

If you have tested positive for COVID-19 or exhibit symptoms that morning, do not attend the trial!

We will give a full refund with proof of a positive test.

DIRECTIONS TO SITE: Industry Hills Expo Center, 16000 Temple Ave, City of Industry, 91744

From the 10 Fwy: Exit Azusa Ave, drive South approximately 2 1/2 miles. Turn Right on Temple and drive 1 mile. Turn Left at first large Iron Gate and follow the road up to the Pavilion.

From the 60 Fwy: Exit Azusa Ave and drive North for approximately 2 miles. Turn Left on Temple and drive 1 mile. Turn Left at first large Iron Gate and follow the road up to the Pavilion.

OVERNIGHT PARKING/ RV's

RV parking with hook-ups must be arranged in advance for this trial at \$50/night (see trial premium). If you haven't sent in your form and payment, contact Stephanie at stephnishimoto@gmail.com by **Monday, Jan 26**.

- All RVs must check in at the Gate and get a parking pass to be displayed on your RV
- Parking spaces for full hook-ups are assigned in advance
- Dry Camping in your RV in the parking lot is \$25.00 per night
- Quiet time is 10 PM to 6 AM

Please do not try to run your electricity to the bathrooms, snack bar, etc. If you did not pay for a hook-up you are not entitled to plug into electricity or hook-up to water ANYWHERE on the property.

SET-UP/SECURITY

On Friday afternoon, competitors can set-up from 3:00 PM until dark. There will be no check-in at that time. There will not be a security guard on the agility site. It is a large, open area – leave things at your own risk.

MEASURING

Ken Boyd is a VMO. He will be measuring dogs between classes (Premier/Excellent/Open/Novice). If your dog needs to be measured, you must have your dog measured ***before your runs*** – before FAST and T2B if you are entered and need to be measured.
