If you pull your dog for any reason, ***and there is someone to take your place***, you will receive a full refund for the class(es) you pull. Wait List pulls ***must be received by Tuesday, Feb 3***. Send an email to Stephanie if you want to pull your dog – stephnishimoto@gmail.com

- 1. Use the South Entrance to the Park.** Follow the posted directions and instructions from the parking attendant. Park in areas marked as parking spaces. You will be sent a map later this week which will let you know where you can enter, park and set-up.
- 2. Dogs must be on leash at all times** except when in the ring or practice ring. Please stay in the show grounds when you are not in the ring. Crating and pottying areas will be identified on the map. Do not enter any other arenas or any other area not indicated as being part of the show site on the map.
- 3. Dog poop MUST be picked up.** There is a \$250 fine from the site if all dog poop is not picked up and disposed in trash cans.

MAPS

Exhibitor maps for the day will be sent by 6 AM via email the morning of the trial and will be available on the Agility Gate App. They will also be posted on the trailer that morning. Printed maps will NOT be available at the trial.

NOVICE AND OPEN COMPETITORS

If you have any questions or need help with anything, please come to the scoring booth and someone there will be happy to help you. If this confirmation is confusing to you and you need some further explanation email stephnishimoto@gmail.com and Stephanie will help you make sense of it.

MOVE-UPS

All pre-show move ups **must be received by 6 PM Monday, Feb 2**. The AKC requires move-ups to be *in writing*. You may send an email for a move-up to stephnishimoto@gmail.com with your name, your dog's call name, the full name and date of the trial and what class you want the dog to be moved to. If you miss the deadline for move-ups, you may move your dog up the first day of the show for any subsequent days even if you are not showing a dog that day. In addition, a friend may do the move-up for you if you are not there. You may not move up the day of the show for that day.

There will be day-to-day move-ups at the show provided the Trial Secretary receives them within 15 minutes after the end of the last class. There will be no move-ups in the morning before the start of the trial.

However, a dog which has been entered in a Novice A class for which it is not eligible to be entered in due to class restrictions on the dog or handler may be moved to the Novice B class under the following conditions: the request for the move must be in writing and presented to the Superintendent or Trial Secretary at least 30 minutes prior to the start of each trial. The request must state the reason and justification for the move from the Novice A class to the Novice B class.

AGILITY GATE APP – Code 2468

DIRECTIONS: Hansen Dam Horse Park, 11127 Orcas Ave, Lakeview Terrace 91342

From the SOUTH (Orange County) take I-5 N toward Sacramento to CA-2 toward Glendale North. In 17 miles take Exit 9 Wheatland Ave toward Lake View Terrace. Turn left on to Foothill Blvd. Turn left onto Orcas Ave. In 0.2 mi take a slight right turn and the site will be ahead on your left.

From the NORTH take I-5 S to 210 E. Take Exit 8 Osborne St and turn left onto Foothill Blvd. Turn right onto Orcas Ave. In 0.2 miles take a slight right turn and the site will be ahead on your left.

From the WEST, take the 118 E to the 210 E towards Pasadena. Take Exit 8 Osborne St and turn left onto Foothill Blvd. Turn right onto Orcas Ave. In 0.2 miles take a slight right turn and the site will be ahead on your left.

From the EAST, take 210 W to Exit 8 Osborne St. Turn left on to Foothill Blvd. Turn left onto Orcas Ave. In 0.2 mi take a slight right turn and the site will be ahead on your left.

OVERNIGHT PARKING/ RV's

RV parking with hook-ups must be arranged in advance for this trial at \$40/night or \$60 for the weekend. If you haven't sent in your form and payment, contact Stephanie at stephnishimoto@gmail.com by **Monday, Feb 2**.

- All RVs must check in at the Gate – you will be sent a parking pass to place on your dashboard
- Parking spaces for full hook-ups are assigned in advance
- Quiet time is 10 PM to 6 AM

SET-UP & SECURITY

Setting up the agility rings is noon-3 PM on Friday. If you would like to help unload the trailer you can come at noon and help unload and set up. **Anyone else will not be able to set up before 3 PM.**

MEASURING

The judge for this weekend is a Volunteer Measuring Official (VMO). He will be available to measure your dog(s) between classes. **If you need to be measured, you MUST be measured before your first run (including T2B and FAST).** If you need help getting measured, come by the scoring booth and we will be happy to help you.

Blvd. In 0.3 mi Turn left after Taco Bell on left onto Colfax Ave. in 1.6 mi turn right after Subway on the right onto Venturn Blvd. 350 ft. turn left to vet.
