Green Oak Ranch is a private facility – there will be a guard at the gate – tell him/her that you are with agility and they will let you in!

NO ALCOHOL ALLOWED – SMOKING IN DESIGNATED AREA ONLY!

Park in the lot next to the field.

Overflow parking will only be available if the main lot is full!

Maps will be emailed the morning of the trial and will be available in AgilityGate

There will not be printed maps for exhibitors at the trial. A map of each course will be posted on the side of the trailer.

AGILITY GATE APP – Code 2468

With the app you can go to a class and check-in, scratch, let the gate know you are FEO or that you have a conflict. When the class is running you can see who is running in the ring. The running order will update automatically as dogs are checked in, when they run, etc. You can stay in your set-up and keep an eye on the running order to see when you are due up. This will keep groups of people from congregating around the gate and help with social distancing. Open and Novice people can see what classes are running to have a better idea how the show is running. Go to the app store that you download your apps from to download it.

Updated COVID-19 guidelines

If you have tested positive for COVID-19 or exhibit symptoms that morning, do not attend the trial! We will give a full refund with proof of a positive test.

At this point, COVID waivers are no longer required.

These guidelines may be modified for different venues OR changes that the State or CDC make. Please check judging schedules for each trial to see what the guidelines will be for that trial. If changes occur after the judging schedule is published, you will be notified by e-mail.

Masks are encouraged for unvaccinated people (per CDC and State recommendation). This will be an honor system - we will not be requiring proof of vaccination. We will not be taking temperatures.

If you are vaccinated, it will be a personal choice whether you want to wear a mask or not.

We encourage everyone to keep social distancing, especially while walking the course. Be aware that people will have different levels of comfort at this time and please respect that.

MOVE-UPS

All pre-show move ups must be received by **6pm, Monday, June 27**. The AKC requires move-ups to be in writing. You may send an email for a move-up to Brenda at agilesam@gmail.com with your name, your dog's call name, the name & date of the trial and what class you want the dog to be moved to. If you miss the deadline for move-ups, you may move your dog up the first day of the show for any **subsequent** days even if you are not showing a dog that day. In addition, a friend may do the move-up for you if you are not there. However, you may not move up the day of the show for that day.

There will be day-to-day move-ups at the show provided the Trial Secretary receives them within 15 minutes after the end of the last class. There will be no move-ups in the morning before the start of the trial.

However, a dog which has been entered in a Novice "A" class for which it is not eligible to be entered in due to class restrictions on the dog or handler may be moved to the Novice "B" class under the following conditions: The request for the move must be in writing and presented to the superintendent or trial secretary at least 30 minutes prior to the start of each trial. The request must state the reason and justification for the move from the Novice "A" class to the Novice "B" class.

DIRECTIONS to Green Oak Ranch, 1237 Green Oak Rd., Vista, CA 92081

Traveling on the 5 from the North or South:

Exit onto CA-78 East toward Vista/Escondido. In 9 mi. take Exit 9 onto Sycamore Ave and turn right. In .8 mi turn right onto Green Oak Rd. The destination is on your right.

Traveling East or West on CA-78:

Take Exit 9 onto Sycamore Ave. Turn south on Sycamore and travel .8 mi. Turn right onto Green Oak Rd. The destination is on your right.

SET UP AND SECURITY:

We are setting up the rings on Thursday afternoon. If you would like to come and help set up you must contact Brenda. Only set up crew will be allowed to set their stuff up. No exhibitor set up on Thursday. This is a private facility. We will not have security of our own. Leave belongings at your own risk.

RV PARKING:

MEASURING:

Our judge is a VMO. He will be measuring dogs for a permanent height card. If your dog needs to be measured, they must be measured before running.

WALK THE COURSES WHILE THE OTHER COURSE IS RUNNING!

When you are done running the first class, walk in the other ring. This will help make the trial run faster.
