**NOTE ON MAPS**: Exhibitor maps for the day will be sent by 6 AM via email the morning of the trial and will be available on the Agility Gate App. They will also be posted on the trailer that morning. Printed maps will NOT be available at the trail.

**FOOD:** The café will NOT be open. Exhibitors will be allowed to drive out and back in once the parking fee is paid for the day. Lunch will be available in lieu of voucher for those workers who sign up by Friday, Feb 4. To reserve a lunch you must contact Pam (see below) by that date.

### **UPDATED COVID 19 GUIDELINES**

# If you have tested positive for COVID-19, do not attend the trial!

These guidelines may be modified for different venues OR changes that the State or CDC make. Please check judging schedules for each trial to see what the guidelines will be for that trial. If changes occur after the judging schedule is published, you will be notified by mail.

Masks are not required outdoors at events. However, masks are encouraged for unvaccinated people (per CDC and State recommendation). This will be an honor system - we will not be requiring proof of vaccination. We will not be taking temperatures.

If you are vaccinated, it will be a personal choice whether you want to wear a mask or not.

We encourage everyone to keep social distancing, especially while walking the course. Be aware that people will have different levels of comfort at this time and please respect that.

### **AGILITY GATE APP - Code 2468**

This is an app for your iPhone or iPad or Android device. With this app you can go to a class and check-in, scratch, let the gate know you are FEO or that you have a conflict. When the class is running you can see who is running in the ring. The running order will update automatically as dogs are checked in, when they run, etc. You can stay in your set-up and keep an eye on the running order to see when you are due up. This will keep groups of people from congregating around the gate and help with social distancing. Open and Novice people can see what classes are running to have a better idea how the show is running. Go to the app store that you download your apps from to download it. You can download the app before you get the code. Maps for the day will be posted on Agility Gate.

#### **NOVICE AND OPEN COMPETITORS**

If you have any questions or need help with anything, please come to the scoring booth and someone there will be happy to help you. If this confirmation is confusing to you and you need some further explanation email <a href="mailto:agilesam@gmail.com">agilesam@gmail.com</a> and Brenda will help you make sense of it.

### **MOVE-UPS**

All pre-show move ups must be received by **6 PM Monday, Aug 15**. The AKC requires move-ups to be *in writing*. You may send an email for a move-up to <a href="mailto:agilesam@gmail.com">agilesam@gmail.com</a> with your name, your dog's call name, the name and date of the trial and what class you want the dog to be moved to. If you miss the deadline for move-ups, you may move your dog up the first day of the show for any **subsequent** days even if you are not showing a dog that day. In addition, a friend may do the move-up for you if you are not there. You may not move up the day of the show for that day.

There will be day-to-day move-ups at the show provided the Trial Secretary receives them within 15 minutes after the end of the last class. There will be no move-ups in the morning before the start of the trial.

**However**, a dog which has been entered in a Novice A class for which it is not eligible to be entered in due to class restrictions on the dog or handler may be moved to the Novice B class under the following conditions: the request for the move must be in writing and presented to the Superintendent or Trial Secretary at least 30 minutes prior to the start of each trial. The request must state the reason and justification for the move from the Novice A class to the Novice B class.

# DIRECTIONS TO SITE: Industry Hills Expo Center, 16000 Temple Ave, City of Industry, 91744

From the 10 Fwy: Exit Azusa Ave, drive South approximately 2 ½ miles. Turn Right on Temple and drive 1 mile. Turn Left at first large Iron Gate and follow the road up to the Pavilion.

From the 60 Fwy: Exit Azusa Ave and drive North for approximately 2 miles. Turn Left on Temple and drive 1 mile. Turn Left at first large Iron Gate and follow the road up to the Pavilion.

REMINDER: \$5 per day parking fee will be collected when you drive in. Exhibitors will be allowed to drive out and back in once the parking fee is paid for the day.

### **OVERNIGHT PARKING/ RV's**

RV parking with hook-ups are arranged in advance for this trial (see trial premium). If you haven't sent in your form and payment, contact Brenda at agilesam@gmail.com.

- Dry Camping in your RV in the parking lot is \$10.00 per night.
- Quiet time is 10 PM to 6 AM.

Please do not try to run your electricity to the bathrooms, snack bar, etc. If you did not pay for a hook-up you are not entitled to plug into electricity or hook-up to water ANYWHERE on the property.

### **SET-UP/SECURITY**

On Thursday afternoon, competitors can set-up from 3:00 PM until dark. There will be no check-in at that time. We

will offer a limited amount of people early set up, if they come in at a designated time, probably around 2:00 PM and help with set up. If you'd like to come early to help with set up please contact Brenda at agilesam@gmail.com otherwise, you will not be let in at the gate till 3 PM. There will not be a security guard on the agility site. It is a large, open area – leave things at your own risk.

#### **MEASURING**

Our judge Tom Slattery is a VMO. He will be measuring dogs for official height cards. If your dog needs to be measured, you must have your dog measured before your runs.
