# **INDUSTRY HILLS EXPO CENTER RULES**

- NO DOGS IN THE BATHROOMS!
- NO PEOPLE AND/OR DOGS ALLOWED ON THE TRAILS
- NO DOGS OFF LEASH
- DOGS ARE ALLOWED IN THE AGILITY ARENA AREA AND MAIN PARKING LOT ONLY
- NO UNLOADING BEHIND THE BLEACHERS OR ON THE DIRT ROAD THAT RUNS ALONG THE ARENA
- PARKING UNDER THE BLEACHERS IS BY INVITATION ONLY!
- THE ONLY PLACE CARS ARE ALLOWED IS IN THE MAIN PARKING LOT IN A DESIGNATED PARKING SPACE

**NOTE ON MAPS**: Exhibitor maps for the day will be sent by 6 AM via email the morning of the trial and will be available on the Agility Gate App. They will also be posted on the trailer that morning. Printed maps will NOT be available at the trail.

#### **NOVICE AND OPEN COMPETITORS**

#### **MOVE-UPS**

All pre-show move ups must be received by **6 PM Monday, Nov 28.** The AKC requires move-ups to be *in writing*. You may send an email for a move-up to <a href="mailto:agilesam@gmail.com">agilesam@gmail.com</a> with your name, your dog's call name, the name and date of the trial and what class you want the dog to be moved to. If you miss the deadline for move-ups, you may move your dog up the first day of the show for any **subsequent** days even if you are not showing a dog that day. In addition, a friend may do the move-up for you if you are not there. You may not move up the day of the show for that day.

There will be day-to-day move-ups at the show provided the Trial Secretary receives them within 15 minutes after the end of the last class. There will be no move-ups in the morning before the start of the trial.

However, a dog which has been entered in a Novice A class for which it is not eligible to be entered in due to class

restrictions on the dog or handler may be moved to the Novice B class under the following conditions: the request for the move must be in writing and presented to the Superintendent or Trial Secretary at least 30 minutes prior to the start of each trial. The request must state the reason and justification for the move from the Novice A class to the Novice B class.

#### **UPDATED COVID 19 GUIDELINES**

## If you have tested positive for COVID-19, do not attend the trial!

We will give a full refund with proof of a positive test.

#### **AGILITY GATE APP - Code 2468**

This is an app for your iPhone or iPad or Android device. With this app you can go to a class and check-in, scratch, let the gate know you are FEO or that you have a conflict. When the class is running you can see who is running in the ring. The running order will update automatically as dogs are checked in, when they run, etc. You can stay in your set-up and keep an eye on the running order to see when you are due up. This will keep groups of people from congregating around the gate. Open and Novice people can see what classes are running to have a better idea how the show is running. Go to the app store that you download your apps from to download it. You can download the app before you get the code. Maps for the day will be posted on Agility Gate.

## DIRECTIONS TO SITE: Industry Hills Expo Center, 16000 Temple Ave, City of Industry, 91744

From the 10 Fwy: Exit Azusa Ave, drive South approximately 2 ½ miles. Turn Right on Temple and drive 1 mile. Turn Left at first large Iron Gate and follow the road up to the Pavilion.

From the 60 Fwy: Exit Azusa Ave and drive North for approximately 2 miles. Turn Left on Temple and drive 1 mile. Turn Left at first large Iron Gate and follow the road up to the Pavilion.

## **OVERNIGHT PARKING/ RV's**

# **SET-UP/SECURITY**

On Thursday afternoon, competitors can set-up from 3:00 PM until dark. There will be no check-in at that time. We will offer a limited amount of people early set up, if they come in at a designated time, probably around 2:00 PM and help with set up. There will not be a security guard on the agility site. It is a large, open area – leave things at your own risk.
