### AGILITY GATE APP – Code 2468

With the app you can go to a class and check-in, scratch, let the gate know you are FEO or that you have a conflict. When the class is running you can see who is running in the ring. The running order will update automatically as dogs are checked in, when they run, etc. You can stay in your set-up and keep an eye on the running order to see when you are due up. Open and Novice people can see what classes are running to have a better idea how the show is running. Go to the app store that you download your apps from to download it.

### MOVE-UPS

---

All pre-show move ups must be received by **6pm, Monday, March 25**. The AKC requires move-ups to be in writing. You may send an email for a move-up to Karyn at [shelties259@gmail.com](mailto:shelties259@gmail.com) with your name, your dog's call name, the name & date of the trial and what class you want the dog to be moved to. If you miss the deadline for move-ups, you may move your dog up the first day of the show for any **subsequent** days even if you are not showing a dog that day. In addition, a friend may do the move-up for you if you are not there. However, you may not move up the day of the show for that day.

There will be day-to-day move-ups at the show provided the Trial Secretary receives them within 15 minutes after the end of the last class. There will be no move-ups in the morning before the start of the trial.

**However**, a dog which has been entered in a Novice "A" class for which it is not eligible to be entered in due to class restrictions on the dog or handler may be moved to the Novice "B" class under the following conditions: The request

for the move must be in writing and presented to the superintendent or trial secretary at least 30 minutes prior to the start of each trial. The request must state the reason and justification for the move from the Novice "A" class to the Novice "B" class.

#### DIRECTIONS to Green Oak Ranch, 1237 Green Oak Rd., Vista, CA 92081

##### **Traveling on the 5 from the North or South:**

Exit onto CA-78 East toward Vista/Escondido. In 9 mi. take Exit 9 onto Sycamore Ave and turn right. In .8 mi turn right onto Green Oak Rd. The destination is on your right.

##### **Traveling East or West on CA-78:**

Take Exit 9 onto Sycamore Ave. Turn south on Sycamore and travel .8 mi. Turn right onto Green Oak Rd. The destination is on your right.

#### SET UP AND SECURITY:

We are setting up the rings on Friday afternoon. If you would like to come and help set up, you must contact Brenda. Only set up crew will be allowed to set their stuff up. This is a private facility. We will not have security of our own. Leave belongings at your own risk.

#### RV PARKING:

There are a limited number of RV parking spots available at this site. RV dry camping is \$30/night. Dry camping will be in the overflow parking area. There is a dump station on site. Contact Brenda ([agilesam@gmail.com](mailto:agilesam@gmail.com)) if you want to park overnight.

#### MEASURING:

Our judge is not a VMO, but we will have a VMO at the trial to be able to measure your dog for an official height card between the classes. If your dog needs to be measured it must be done before your run.
