AGILITY GATE APP – Code 2468

With the app you can go to a class and check-in, scratch, let the gate know you are FEO or that you have a conflict. When the class is running you can see who is running in the ring. The running order will update automatically as dogs are checked in, when they run, etc. You can stay in your set-up and keep an eye on the running order to see when you are due up. Go to the app store that you download your apps from to download it.

Updated COVID-19 guidelines

We will give a full refund with proof of a positive test.

MOVE-UPS

All pre-show move ups must be received by **6pm, Monday, July 8**. The AKC requires move-ups to be in writing. You may send an email for a move-up to Karyn at agilesam@gmail.com with your name, your dog's call name, the name & date of the trial and what class you want the dog to be moved to. If you miss the deadline for move-ups, you may move your dog up the first day of the show for any **subsequent** days even if you are not showing a dog that day. In addition, a friend may do the move-up for you if you are not there. However, you may not move up the day of the show for that day.

There will be day-to-day move-ups at the show provided the Trial Secretary receives them within 15 minutes after the end of the last class. There will be no move-ups in the morning before the start of the trial.

However, a dog which has been entered in a Novice "A" class for which it is not eligible to be entered in due to class restrictions on the dog or handler may be moved to the Novice "B" class under the following conditions: The request for the move must be in writing and presented to the superintendent or trial secretary at least 30 minutes prior to the start of each trial. The request must state the reason and justification for the move from the Novice "A" class to the Novice "B" class.

DIRECTIONS TO GEORGE INGALLS EQUESTRIAN CENTER:

Address for GPS: The George Ingalls Equestrian Center main entrance is just past the Norco Animal Control Center at 98 Sixth St., Norco, CA 92860. Use this address to be directed towards the main entrance and the first arena.

From the 91/I-15 Northbound – Exit Sixth Street and turn right. Go past Pike’s Peak Park. The site is at the top of the hill – approximately 2 miles from the freeway. We are in the first arena.

From the I-15 Southbound - Exit Sixth Street and turn left. Go past Pike’s Peak Park. The site is at the top of the hill – approximately 2 miles from the freeway. We are in the first arena.

SET UP AND SECURITY:

We are setting up the rings on Saturday morning. This is a private facility. We will not have security of our own. Leave belongings at your own risk.

OVERNIGHT RV PARKING

MEASURING:

Our judge is a VMO. He will be able to measure your dog for an official card . If your dog needs to be measured it must be done before your run.

CHECK-IN AND RUNNING ORDERS:
